The Prohibition Party of New York Moving Forward

In 2017, we began the process of reestablishing the state party organization in New York. As it stands, the Prohibition Party of New York is in its early stages of building itself up as an organization. We have a starting group of members, are working to spread awareness of our group, are working to recruit new members, have been engaging in activism, and have been working to grow our organization.

Moving forward, we seek to establish the Prohibition Party of New York as a fully functioning state party organization, with a formally established state party committee and the infrastructure needed to fully act as non-state recognized minor party in New York.

In order to establish a full state party committee, we must first work to recruit enough members that we will a sufficient pool of people for filling leadership and committee positions. Now we don't have a precise number for this. But, we would need to have people to fill at least the roles of chairman, vice-chairman, secretary, treasurer, and about 3-5 executive committee members. In addition, we could use some people to fill the roles of regular state committee members, and other organization positions that we may create. To this end, we will work to recruit as many good new members as we can, and work to find those people who could be well suited for filling the needed leadership positions. Once we are convinced that we have grown enough to do this, we will begin planning for some form of state convention, where we will formally establish a state committee, as well as establish a state group charter, and bylaws.

Another key step in our development will be establishing a state group account.



That way, we can begin to raise and spend money for our group activities, and thus have a wider range of possible activities. Once we can get a state group treasurer, we can begin the process for this.

Once, we have our state committee established, we can begin the process for gaining the legal recognitions we will need to formally operate in the state. The first key step for that will likely be working to apply for status as a 501C4 organization. If we can gain status as 501C4 organization, then we will have the legal security to b able to raise and spend money for our state party operations, messaging, and activities. Although this status will come with limitations and political spending and won't allow us to directly fund the campaigns of our candidates. Though that will be addressed in the next step.

Once we have 501C4 organization status for our state group, we could then work to establish a separate political action committee to raise and spend money for supporting Prohibition Party candidates in the state. And once these steps are done, we'll have completed our early stage of organizing, and will have the basic elements needed for a non-state recognized minor party. These steps taken together will likely take years to complete. But the more we work in the near term to advance these things, the sooner we can accomplish them. And once we have securely established our state party organization in New York state, we can work towards one day growing large enough to become a state recognized party, with ballot access.

On the Assembly Campaign Trail

Prohibition Party of New York organizer Jonathan Makeley is running for the 146th district of the state assembly, and is seeking to get on ballot via independent nominating petition. In the lead up to the petition signature collecting period (which starts in mid-July), Makeley has been working to build up his campaign and reach voters.

Here are some recent details on his campaign. On May 21st and May 22nd, Makeley attended two neighborhood meeting events (for Getzville and Audubon) held by the Town of Amherst, as it works to prepare its comprehensive plans for the town.

In describing the events, Makeley stated:

"I just finished attending today's Amherst neighborhood input meeting at the Getzville Fire Station. Nice to see so many people gather to have a say in the future of their community. I saw incumbent assemblymen Ray Walter, who was there for about the first 15 minutes of the event. As for me, I was there for the entire event. I had the pleasure of talking with several people about issues related to the town of Amherst and hearing comments from various people about the town's condition and where they would like to take it.

The conversations in the event also brought up some issues which are more broadly relevant to the state. The burden of property taxes, the rising costs of living, the need to improve infrastructure, the tensions between developers and community members, and the need to reduce the number of places selling alcohol.

In the course of my campaign I hope to help address these issues with my advocacy for stronger policies for promoting the public wellbeing, reforming the state fiscal system to reduce the burden of property taxes, improving infrastructure, and a holistic approach to economic development which takes into account the wellbeing and interests of communities. And in the course of my campaign, I hope to speak with plenty more of the people in the district."

"Today I attended the Amherst input meeting for the Audubon neighborhood. As with the Getzville meeting, it's nice to see so many people gather to have a say in the future of their community. I had the pleasure to speak with and hear from various community members about their thoughts and aspirations for their communities.

The conversations at this event also touched on issues that are important on a statewide scale. Such as the importance of good quality schools. As a candidate, I support policies to maintain and improve the quality of education.

As we move forward with this campaign, I hope to have the opportunity to interact with plenty more people across the district."

State Activism Interview, With Dale Driscoll on Brittany's Law

This is the first article for our state activism interview segment. In this article, we interviewed Dale Driscoll, who is an advocate for Brittany's Law. Brittany's Law is a proposed bill, which would establish a state registry for those convicted of violent felonies, similar to the current system for sex offenders.

Here is the content of our interview

Would you mind telling our readers what Brittany's law is?

Brittany's Law Domestic/Violence
Prevention Act would require violent
felons to register, similar to the sex
offender registry except with the violent
felons it wouldn't be life long. There
would be a panel of 5 created by the
sponsor of the bill in the Assembly, This is
how it was explained to me: Aileen
Gunther's bill creates a 5 member board
that determines the level status, after that
Level 1 and 2 offenders are registered for

10 years, Level 3 is minimum of 10 years until a court determines the person is no longer a threat. Most of these acts of violence are domestic violence related, such as choking, strangulation, use of a deadly weapon, imprisonment or kidnapping and of course murder. 77% of violent felons will abuse their partners.

In May of 2009 my daughter Helen started dating John Brown. Helen knew he was on parole, but not for the actual reason. He had told her he was in a bar room brawl over a girl, when in actuality he had thrown his infant child into a wall causing permanent brain damage. Both of these charaes would fall under assault in the 2nd which is what was stated on the Dept. of Corrections Website. Yes, Helen did look him up, but I have to tell you, if you don't at least have the persons birthday it's nearly impossible to find who ever you might be looking for. There was also no mention of child abuse of the DOC's website. There is NOT enough information given on the DOCS website and it's too difficult to find anyone.

- 1. Had she known the actual charges she never would have allowed this
- 2. man anywhere near her underage children.
- 3. John Brown wasn't allowed to be around his own children, so I had to ask, why was he allowed to move in with my daughter and her underage children?
- 4. .John Brown frequently violated the conditions of his parole, yet nothing was ever done. I can't blame the parole officers for this. They were told by the state NOT to send parolees back because of over crowding in the prisons. Because of the numerous violations he did have to meet with his parole officer and his boss the day before he killed them. He was given, what they called a get out of jail free card. In other words, as long as he agreed to work for them as an informant once his parole was complete he would not be sent back to prison. Allowed to stay out only to kill my daughter and 12 year old granddaughter Brittany the next day, Nov. 20, 2009. The reason he killed Helen? She broke up with him. As for Brittany, because she went to her mothers defense and tried to save her. The system failed them and the system continues to fail us.

William F. Varney: The Attempted **Preserver**

William Fredrick Varney was born on October 1st, 1884, in Patterson, New Jersey. He as the son of Rev. F.W. Varney. He worked in the textile industry in New Jersey and Long Island from 1902 to 1919, and had worked as an insurance agent from 1919, to 1957. At some point he established his permanent home in Rockville Centre, New York.

Varney joined the Prohibition Party in 1906. In 1910, he ran in the 1st district of the New York State Senate. He received 458 votes (1.51%) and came in 3rd place. He was country chairman for the party in 1912.

He worked as a field secretary for the Prohibition Party in New Jersey from 1912 to 1919. He had helped direct successful election campaigns in Gloucester County in 1914.

In 1924, he was considered as a possible nominee for President at the 1924 convention and came in 3rd place, behind 1924 Prohibition Party candidate Herman P. Faris, and A.P. Gouttey. He served on the Prohibition National Committee for New York from 1924-1928.

In 1928, the condition for the Prohibition Party was somewhat grim. There were challenges against national prohibition. The promise of Republican candidate Herbert Hoover to protect prohibition, combined with anti-Catholic backlash against Democratic candidate Al Smith served to pressure voters to vote for Hoover instead of the Prohibition Party candidate, and elements of the Prohibition Party wanted to shy away from challenging Hoover. But William Varney through his hat in the ring and become the party's 1928 candidate for President.

During the 1928 election, Varney campaigned for strengthening enforcement of national prohibition. He stated that "The wet and dry issue is the only real issue in the coming campaign. I will abide no consideration of religious prejudice in my fight for the presidency. This is a free country and its people have the right to vote any way they please regardless of religious beliefs."

"I could never identify myself with a party which licensed the traffic of alcohol,"

"A divided constituency will never achieve the enforcement of prohibition. Lincoln said no man can be half slave and half free. I maintain no party can be half wet and half dry. There should be no pussyfooting."

In the election, he received 20,106 votes. While these results may not have been large compared to previous elections, Varney still managed to do fairly well, given the challenging circumstances he was in.

In 1932, Varney ran for New York's 1st congressional district. He received 4,195 votes (1.48%), and came in 4th place. And in 1933, he ran for Mayor of Rockville Center.

In 1934, Varney ran as the Prohibition Party candidate for governor under the Law Preservation ticket (at the time the New York Prohibition Party was using name Law Preservation, in connection to its support for preserving national prohibition). He received 20,449 votes (0.54% and came in 5th place). Unfortunately, this was not enough votes for the Prohibition Party to be able to maintain its automatic ballot access in the state.

Since that election, the Prohibition Party has not been able to get a candidate for Governor on ballot in New York in any election so far. Though the New York Prohibition Party continued for some time after that. In 1936, Varney was state chairman, and the Prohibition Party held its national convention in Niagara Falls, New York. The Prohibition Party managed to continue placing candidates on ballot for various offices in the state up to 1940.

Though the Prohibition Party may have lost its ballot access in New York and eventually lost its state organization for a time, Varney had valiantly sought to preserve it. Varney passed away of December 14th, 1960.

Efforts to Protect Children

Earlier this year, there was a strong effort to pass the Child Victims Act: a bill which would have helped advance justice for victims, by extending or eliminating the statute of limitations for the sexual abuse of children. The bill had been proposed as part of the 2018 state budget, but unfortunately it wasn't included in its final passage. Though, there are still efforts to pass bills for advancing justice for the victims of childhood sexual abuse.

There are some proposed bills in the state legislature to set up a fund for compensating victims of abuse and for making it easier for victims to sue for restitution. There has also been proposed legislation for eliminating the statute of limitations for the sexual abuse of children.

A we have said before, the state of limitations for rape and the sexual abuse of children is an unjust and arbitrary deadline, which serves to deny justice to victims and allows predators to run free. Hopefully the state legislature will successfully abolish the statute of limitation for the sexual abuse of children and advance other such measures for combating sexual abuse and helping those who have suffered from it.

The Search for a State Party **Treasurer**

As we move forward in building the Prohibition Party of New York, we will need to find people who are well suited to filling leadership roles. After the state chairman, the next most crucial position to fill is that of the state treasurer. The state treasurer is needed to establish a full state committee, to establish a state party account, and for us to legally register our organization. Thus, it is important for us to find a good person who can take up the position.

A state treasurer would need to be someone who well fits these four types of qualifications:

- 1. Someone who would know how to open and manage a group bank account.
- 2. Someone who will be able to will be able to handle financial paperwork. Including the paperwork for opening and managing a group account, and their part of the paperwork that will be involved with seeking 501c4 status.
- 3. Someone who will have the time and availability to perform the job in the coming years.
- 4. Someone who we can find to be trustworthy enough for the responsibilities of the position.

Once we are able to find a state treasurer, then we will have taken a big step forward in building up our state party organization.

Interview with Dale Driscoll: Continued

Would you mind sharing as to why it is that you are advocating for Brittany's law?

I believe this bill will save thousands of lives and I have the backing of so many, (Brittanys Law FB Group alone has over 1500 members) that want this bill passed and cannot understand why it hasn't. I advocate for domestic violence as a whole because I want to bring awareness. There are so many red flags to look for, but until someone is in a violent relationship, and go for help they are unaware of what these red flags are. We NEED education.

What is the current status of the effort to pass Brittany's Law through the New York state legislature?

We also have the backing of the whole NYS Sheriffs Association. This bill S1107 is currently in the Finance committee of the Senate. Once it gets out of committee it will go to the full Senate floor for a vote. It is expected to pass again, as it has for the past 7 years. It then gets sent to the Corrections committee in the Assembly, where it has stalled every year.

If someone was looking for more information of Britany's Law, where could they look for it?

If anyone wanted to learn more about Brittany's Law they could simply google Brittany's Law NYS. There is a lot of information out there, there are also several conferences on YouTube, again just search Brittany's Law.

If someone is interested in doing something to help support Brittany's Law, what sort of things could they do?

There are 3 key people that people could call to help get this passed. The bill number in the assembly is A404. They will ask for this.

Prohibition Party News Across the Nation

Here is some news for the Prohibition Party Nationally:

National Committee Member Richard Swift has been working to promote the party in Illinois. Recently he managed to get an article printed in the Dispatch Argus newspaper, in which he encouraged people to consider the Prohibition Party as a third party option, to help address the needs and convictions of Illinois voters.

In Georgia, national chairman Rick Knox had been trying to acquire the Republican nomination for lieutenant governor. But Knox was unable to gain the nomination.

In Mississippi, there was hope that Prohibition Party candidate for Congress, Bill Bayes, could have become the first prohibitionist to get on ballot for congress in over 30 years. Unfortunately, we have received word that Bill Bayes had to end his campaign due to health problems. We wish Mr. Bayes well in his recovery.

In Tennessee, the Prohibition Party has endorsed Ronnie Holden, a candidate for the 47th district of the Tennessee State

The Partisan Prohibition Historical Society is currently working on producing a new book on the history of the Prohibition Party up to the 2016 elections. There is currently no set date on when the book will be completed. Though party

members and other select individuals will be able to request a free copy of the book when it is out, and more details will be given by the national Prohibition Party in the future.
